CRITERIA

Nominees should have demonstrated outstanding accomplishments and/or contributions in the state of North Carolina, which represent a lifetime of achievement, regardless of age.

Examples may include, but not limited to:

- Community service
- Professional leadership
- Advocacy on women's issues and initiatives

QUALIFICATIONS

- May be living or deceased
- Must be (or have been, if deceased) a native of North Carolina or have resided in the state for at least 10 years.

PROCESS

- A nomination application must be submitted.

- Self nominations are accepted.
- Nominees will be reviewed and selected by a statewide panel of judges.

SELECTION TIMELINE

- Applications for 2010 must be received by May 31, 2010.
- Inductees selected in July 2010.
- Nominees and nominators will be notified of the judges' decision by August 2010.

An induction program will occur during a general session of the 2010 North Carolina Governor's Conference for Women on November 9 in Raleigh.
